2. Sustainable Agriculture

- a. Robert provided an update on the Urban Agriculture Committee. They discussed zoning codes, enforcement codes, and a memo to the City about loosening regulations to allow for more types of agriculture in the City.  - The funding from NACD is being used to connect food centers with local farmers. An event is being held at the Community food Club to showcase this partnership.
- f. RCPP Project Updates
 - i. EQIP sign ups
 - 6 applications, NRCS is developing conservation plans for about \$80,000. Working through process with contracts. Once obligated, cover crops, forest management, wildlife habitat, tree & shrub planting, and pollinator habitats will be installed.
 - 2. Total funds to date: \$1.2M obligated, 55 conservation plans, 17,000 acres.
 - ii. Ottawa County RCPP
 - Obligated funding is almost \$1M already. \$60,000 left to maybe use for irrigation, most of the funding went to cover crops, some farmland preservation.

 - a. EPA Equitable Resilience Building Tool workshops: LGROW hosted workshops in the Buck Creek, Indian Mill / Mill Creek, and Plaster Creek subwatersheds.
